Sub: Introduction of Online Dispute Resolution Mechanism

Securities and Exchange Board of India ("SEBI") vide Circular Nos. SEBI/HO/OIAE/ OIAE_IAD-1/P/CIR/2023/131 dated July 31, 2023 and SEBI/HO/OIAE/OIAE_IAD-Circular 1/P/CIR/2023/135 dated 2023 August 04, and Master SEBI/HO/OIAE/OIAE_IAD-1/P/CIR/2023/145 (updated as on August 11, 2023) has introduced a common Online Dispute Resolution Portal ("ODR Portal") to facilitate online conciliation and online arbitration for resolution of disputes arising in the Indian Securities Market.

In view of the above, the new procedure of raising complaints / disputes under the investor grievance redressal mechanism is provided below:

An investor shall first take up his/her grievance against the Bank by lodging a complaint directly with the Bank or Bank's Registrar and Transfer Agent (RTA).
