**Intimation to Shareholders holding shares in physical form**

**Subject: Updation of PAN, Nomination, Contact Details, Bank Account Details or Specimen Signature in the Folio(s)**

Dear Shareholders,

We would like to bring to your attention that SEBI, vide its circular dated [November 03, 2021](#) (subsequently amended by circulars dated [December 14, 2021](#), [March 16, 2023](#), [May 17, 2023](#) and [November 17, 2023](#)) mandated that the shareholders (holding securities in physical form), shall update/furnish the PAN, Nomination, Contact Details, Mobile Number, Bank Account Details and Specimen Signature in their folio(s). Further, SEBI vide its circular dated [June 10, 2024](#), has made an exemption for submitting 'choice of nomination'. However, Bank encourage the shareholders who are holding shares in physical form for registering the nomination in their Folios.

Hence, all shareholders who are holding shares in physical form are requested to note the following:

- In case of non-updation of PAN or Contact Details or Mobile Number or Bank Account Details or Specimen Signature in respect of physical folios, **dividend shall be paid only through electronic mode with effect from April 01, 2024 upon furnishing all the aforesaid details in entirety.**
- If a shareholder updates the PAN, Contact Details including Mobile Number, Bank Account Details and Specimen Signature after April 01, 2024, then the shareholder would receive all the dividends declared during that period (from April 01, 2024 till date of updation) pertaining to the shares held after the said updation automatically.

In view of the above, **all shareholders who are holding shares in physical form and not updated the PAN, Nomination, Contact Details, Mobile Number, Bank Account Details and Specimen Signature in their folio(s)** are requested to update/furnish the same in their folio immediately. The prescribed forms are also available on the website of the Bank at <https://www.kvb.co.in/investor-corner/share-holder-faq/> and website of Bank's RTA at <https://liiplweb.linkintime.co.in/KYC-downloads.html>. The duly filled and signed forms shall be sent to the Bank's RTA as below:
