

## Postal Ballot Notice

Members are hereby informed that pursuant to Section 110 of the Companies Act, 2013 read with Rule 22 of the Companies (Management and Administration) Rules, 2014 that the Bank has, on Saturday, March 24, 2018

(i) completed the dispatch of Postal Ballot Notice along with the Postal Ballot Form and a self-addressed business reply envelope by Registered Post to the Members of the Bank who have not registered their e-mail addresses either with the Depositories or Registrar and Share Transfer Agent (RTA) of the Bank M/s SKDC Consultants Limited, Coimbatore and

(ii) sent Postal Ballot Notice by e-mail through National Securities Depositories Ltd (NSDL) along with the details of Login ID and Password to the Members of the Bank who have registered their e-mail address with the Depositories or with the RTA.

for seeking approval of the members of the Bank through Postal Ballot including voting through electronic means (e-Voting) for the resolution as under:

01	To approve the Karur Vysya Bank Employees' Stock Option Scheme, 2018 ("KVB-ESOS-2018")

The Notice has been sent to all the members, whose names appear on the Register of Members/list of Beneficial Owners as received from the depositories on Wednesday, March 21, 2018, i.e., 'the cut-off date'. The voting rights of members shall be in proportion to their shares of the paid-up equity share capital of the Bank as on the cut-off date.

The Bank has appointed Shri CS S Solaiyappan, Practicing Company Secretary as the Scrutinizer for conducting the Postal Ballot process in a fair and transparent manner.

Pursuant to Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Amendment Rules, 2015 and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Bank has engaged the services of NSDL for providing e-Voting facility to all the Members. The detailed procedure for e-Voting is furnished in the Postal Ballot Notice. The e-Voting period commences on Monday, March 26, 2018 from 10.00 a.m. onwards and ends on Tuesday, April 24, 2018 till 5.00 p.m. The e-Voting module shall be disabled by NSDL for voting thereafter. Members can opt for any one mode of voting i.e., either by Postal Ballot or e-Voting. In case Members cast their votes through both the modes, voting done by e-Voting shall prevail and votes cast through Postal Ballot Form will be treated as invalid.

Members who are voting through Postal Ballot Form may send the duly completed forms so as to reach the Scrutinizer not later than 5.00 p.m. on **Tuesday, April 24, 2018** at the address mentioned on self-addressed business reply envelope. Any Postal Ballot Form received after this time and date will be treated as if the reply from the Member has not been received.

Postal Ballot Notice and Form are also available on website of the Bank www.kvb.co.in. Members who have received Postal Ballot Notice by e-mail and who wish to vote through Postal Ballot Form may download it from the website of the Bank or from the link https://evoting.nsdl.com/.

The result of the Postal Ballot along with the scrutinizer's report would be announced on or before **Thursday**, **April 26, 2018, by 5.00 p.m.** at the Registered Office of the Bank and also be displayed at the following websites www.kvb.co.in, www.evoting.nsdl.com, www.nseindia.com and www.bseindia.com.
